### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

- First-aid measures general : Check the vital functions. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen. Victim conscious with laboured breathing: half-seated. Victim in shock: on his back with legs slightly raised. Vomiting: prevent asphyxia/aspiration pneumonia. Prevent cooling by covering the victim (no warming up). Keep watching the victim. Give psychological aid. Keep the victim calm, avoid physical strain. Depending on the victim's condition: doctor/hospital.
- First-aid measures after inhalation : Remove the victim into fresh air. Respiratory problems: consult a doctor/medical service.
- First-aid measures after skin contact : Wash immediately with lots of water. Soap may be used. In all cases of doubt, or when symptoms persist, seek medical attention.
- First-aid measures after eye contact : Rinse immediately with plenty of water for 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Take victim to an ophthalmologist if irritation persists.
- First-aid measures after ingestion : Rinse mouth with water. Do not induce vomiting. Give 2-3 glasses of water to drink. Consult a doctor/medical service if you feel unwell. Ingestion of large quantities: immediately to hospital.

#### 4.2. Most important symptoms and effects, both acute and delayed

- Symptoms/injuries after inhalation : None under normal use.
- Symptoms/injuries after skin contact : Contact during a long period may cause light irritation.
- Symptoms/injuries after eye contact : Irritation of the eye tissue.
- Symptoms/injuries after ingestion : Nausea. Vomiting. Diarrhoea. AFTER ABSORPTION OF HIGH QUANTITIES: Disturbances of heart rate. Respiratory difficulties.
- Chronic symptoms : ON CONTINUOUS/REPEATED EXPOSURE/CONTACT: Gastrointestinal complaints. Affection of the renal tissue. Disturbed tactile sensibility. Paralysis.

#### 4.3. Indication of any immediate medical attention and special treatment needed

Treat symptomatically.

#### 5.3. Advice for firefighters

- Precautionary measures fire : Exposure to fire/heat: keep upwind. Exposure to fire/heat: consider evacuation. Exposure to fire/heat: have neighbourhood close doors and windows.
- Protection during firefighting : Fire fighters have to wear suited clothing and an independent repertory device (SCBA) that covers the face completely with pressure. Clothing for fire fighters (including helmets, protective boots and gloves) according to European Regulation EN 469, give a basic protection level for an incident with chemicals.
